Editorial

Brigade Resume'

Hello, as I stated in the Secretary/Treasurer's report I am now responsible for the aforementioned position on the RFA committee, the following is a short heads-up for your perusal. In January of 1962 I joined the local Research Rural Brigade as the area was regularly being threatened by bush fires. After 5 years as a firefighter the members elected me to the position of 4th Lieutenant and when the 3rd Lieutenant's position fell vacant the members again voted for me to take over the role.

Like many other volunteers I believe the role influenced me to apply to join the MFB and in 1968 I successfully became a recruit firefighter in the Metropolitan Fire Brigade. A position I held for over 20 years. The training, skills and knowledge I gained there was not only of great assistance to my personal development it also enabled me to keep the other members of Research brigade aware of any recent development or protocol in firefighting technology.

In 1971 I was elected to the position of Captain of the Research Rural Fire Brigade, unfortunately because I was an active member of the UFU it became apparent to me that I may, because of my position of office in the rural brigade, create conflict so I resigned from my position of office with the CFA.

I continued to remain a volunteer firefighter carrying out the role in the protection of life and property from fire in the community. During this time I was instrumental in building up a brigade tanker from a cab chassis which the Brigade purchased from Ford at a very good price. A year later, after many man hours a firefighting appliance with a 400 gallon tank, pump, equipment, lights and siren was born and commissioned to the Brigade. This vehicle was a great adjunct to the brigades firefighting ability.

In 1992 I was elected by the Lower Yarra Group as a DGO (Deputy Group Officer and in 1994, elected to the position of Group Officer, which I held until 1996. During this time it enabled me to make many improvements to operations, including the purchase of the Lower Yarra Control Unit.

In 1983 I was awarded the National Medal for service in the MFB and in 1987 was made a Life Member of the Research Fire Brigade, then in 1997 I was awarded Honorary Life Membership of the CFA.

The Officers and Members of the Research Fire Brigade fully supported that Ex-Captain Allan Roberts be awarded a National Medal Clasp (first) for over 35 Years of diligent service to the Country Fire Authority of Victoria. (I now have 2nd and 3rd Clasps).



In 2008 the Brigade elected me as 2nd delegate to VFBV Region 13; in 2009 I was elected as region 13 VFBV State Councilor until 2011.

When the Districts changed I was elected by the Brigade as VFBV Delegate to District 14.

During my career with the MFB, back in 1984, I applied for a position in the Driving Department and in 1988; I took the option of early optional retirement to explore other successful business opportunities.

I am still a volunteer with the Salvation Army Emergency Services at major fires & emergency situations when required

In 2007 I became a Director of the Firefighters Credit Union. From 2009 to 2011 I was Chairman of the Board.

As this position is only for 2 years at a time in November 2011 I reverted back to being a Director and am still current.

At the moment I am still Training and Assessing CFA Volunteers on driving CFA Vehicles.

In 2012 I received my 50 year service award.

In 2015 I will have completed 53years as a registered volunteer Firefighter with the CFA.

I have been an active member of the RFA since 1990 and I believe my firefighting background and my business accruement would assist in the role of the Retired Firefighters Association Secretary / Treasurer Position and this is why I put my hand up for the role.

Employee Support Program Update

Post-traumatic stress.

Hello everyone, welcome to 2015. So far we in these newsletters we have covered an introduction to the Employee Support Program and some information on the wellbeing checks that are offered to all MFB employees.

I would like to focus on this article on some information on Post-Traumatic Stress. I will apologise at the outset if this reading triggers some unpleasant memories for you or family but this term is attracting more and more interest and it is good to understand the nature of the problem. Two important things to remember: firstly, some psychological distress following exposure to traumatic events is completely normal. Secondly, the longer you go without doing something about the longer term effects, the harder they are to treat.

When we talk about Post traumatic stress, the following symptoms may or may not be included: trouble sleeping, trouble eating, difficulty concentrating, feelings of constantly “walking on eggshells”, and a tendency to want to isolate yourself from others (social withdrawal). There is a marked need to avoid anything to do with the event that has triggered the traumatic response, including avoiding memories, activities, places, and people. I have heard stories of firies driving an extra suburb on days off just to avoid a place where a particular turnout took place, although they are continually exposed to the area during their shift. Generally people affected by PTS don't remember the whole event exactly. Flashbacks may occur in disjointed snippets that may not make sense to them. These “flashbacks” are not memories. They can't be quickly controlled by the person experiencing them and are more like an actual replaying of the event, with smells, sounds, images, thoughts, the whole lot. Recurring distressing dreams may also occur.

The biggest symptom to come out of the current research is the development of anger, expressed through behaviour, words, thoughts, and / or feelings. According to the diagnostic manual for PTS and other disorders of mental health (DSM-V), two things have to be present for the illness to be formally diagnosed:

- 1: The person experienced, witnessed, or was confronted with an event or events that involved actual physical or threatened death or serious injury, or a threat to the physical integrity of self or others;
- 2: The person's response involved intense fear, helplessness, or horror.

Given what firies are exposed to in the course of their

careers, 1 and 2 may certainly be experienced. Although one may not be directly exposed to death and or serious injury one can certainly feel trauma from witnessing what others go through. The introduction of Emergency Medical Response (EMR) some years ago has seen firies come into contact with distressed relatives and bystanders who may be angry or even aggressive, or showing intense signs of grief and shock. These highly emotional people can “stay” with a person for a while.

As humans, we are essentially “pack animals”. We thrive on social networks and a feeling of connectedness to others. So their distress is going to affect us to a degree. This does not mean we are suffering psychologically. It is when we can't get these people out of our heads after a long time that we may need help to “lay them to rest”.

In terms of PTS, again using animals as a comparison, it is normal when confronted with something startling to want to either fight it or run away, classic “flight/fight” stuff. If our bodies haven't dealt with processing the ordeal we may get stuck in a pattern where the primitive part of our brain thinks the threat isn't over. This can be very hard for the higher functioning level of our brain to master. So as irrational as it feels we lose sleep, can't eat, feel angry, feel on edge, isolate ourselves, and keep being haunted by those thoughts and feelings that won't go away. Some may even start to drink alcohol, which while giving short term relief doesn't help in the long run.

Remember, PTS disorder is an anxiety disorder, not depression. Depression comes into it when you are so exhausted physically and mentally that you start to “shut down”.

Doctors may diagnose acute stress disorder if symptoms last one to three months. Anything longer than three months and you are potentially in the PTSD category. Remember the symptoms described in the short term are normal reactions to abnormal events. You are not “crazy” or in the “head bin”. You do need to talk to someone though, and try to exercise, even walking, as these physical symptoms need space to be released, even in the short term. Just as importantly, many will go their entire careers without being affected. This is also “normal”!

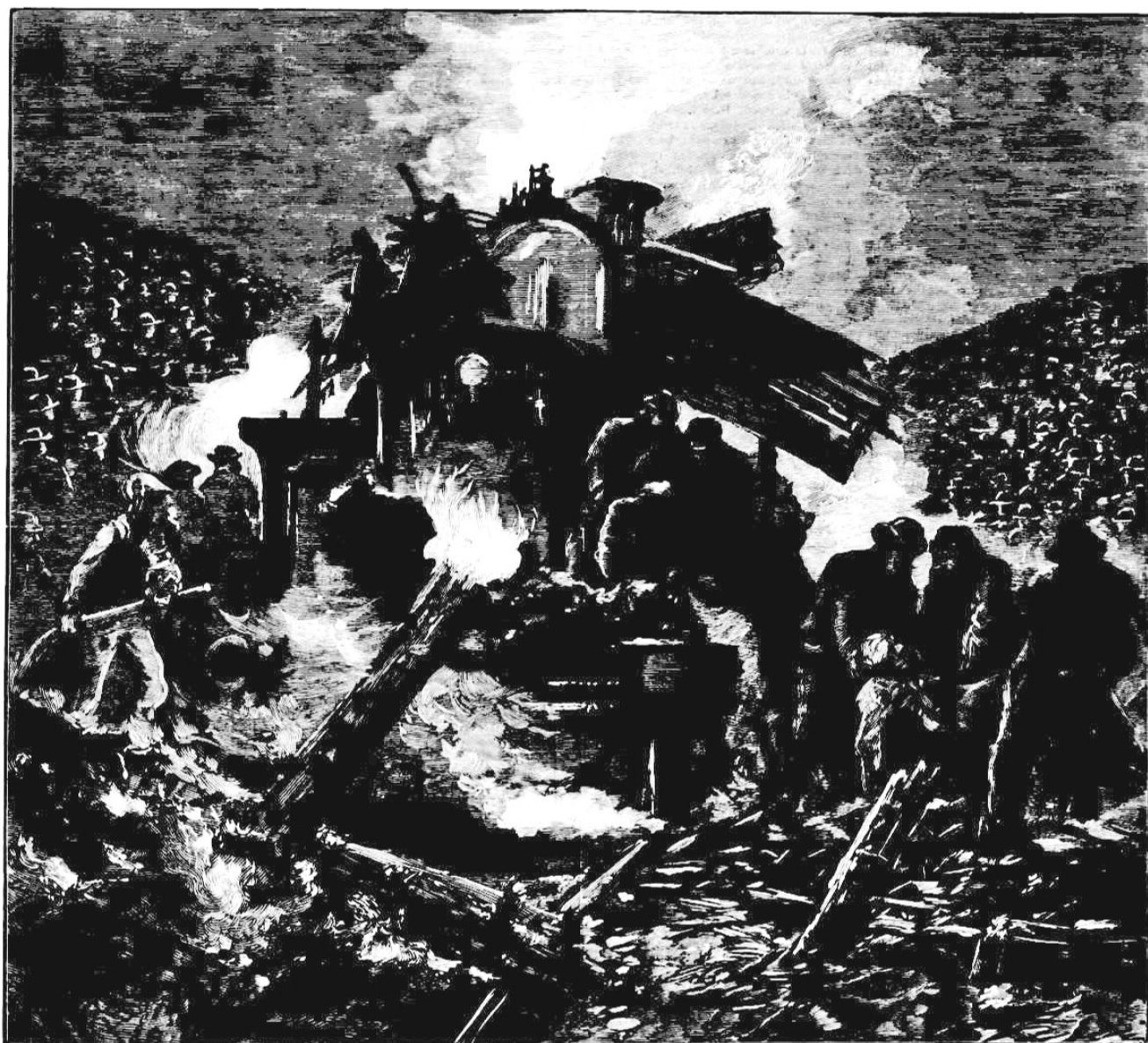

Melbourne's Fire Heritage Prior to the MFB.

'Water Off' continues with its series on fires and fire brigades in Melbourne before 1891, when the Metropolitan Fire Brigade became the only Fire Brigade in the metropolis.

This edition's topic is the collision of two suburban trains near the Windsor train station in 1887. The following is a brief account of the tragedy from the Melbourne newspapers of the time - *The Argus*, *The Illustrated Australian News* and the *Australasian Sketcher*.

The Windsor Train Collision. May 11, 1887

The large text headlines in 'The Argus' on the morning of May 12 left little doubt that a serious incident had taken place the night before....

"Shocking Railway Disaster"
"A Terrible Collision"
"Serious Loss of Life"
"Many Passengers Injured"
"Two Men Roasted To Death"

Everything was normal on the afternoon of Wednesday May 11, when the 5.30 p.m ordinary train, packed with passengers going home from work, left Flinders Street Station. It had stopped at all stations, and by the time it reached Prahran many of the passengers had already got off at their various destinations.

Ten minutes later, at 5.40 p.m an express train departed from Flinders Street Station for Brighton. Also packed with passengers, it usually ran express to Windsor and then stopped at all stations to Brighton.

About 300 yards from the Windsor Station, on a sharp curve in the track in a steep cutting, the hose pipe of the Westinghouse steam brake on the ordinary train burst and brought the train to a standstill, locking the wheels and making them immovable. The guard got down to see if anything could be done to rectify the problem. He knew about the express train somewhere behind his train, but assumed that the red signal would stop it before it reached them.

Both trains should have been protected by the block system, the vital principle of which was if the correct procedures were observed, a clear distance would be maintained between the ordinary train and the express. If the express gained distance on the ordinary train, it would be stopped by a red signal. A white signal would indicate a safe distance between the two trains and it could proceed. The block system worked very efficiently, so on the night of the collision it seemed that one or more persons must have disregarded the warnings.

Approaching Windsor Station at speed, Maskell, the driver of the express could not see the disabled ordinary

train due to the bend in the track just beyond the High Street Bridge. The crash was only seen to be inevitable immediately before it occurred. Some of the ordinary train passengers, on hearing the long blast of the express train's whistle, escaped by jumping out of their train just in the nick of time, but the others stayed in their seats.

Rounding the curve, sighting the stationary train and realising the imminent danger, in that split second, Maskell reacted instinctively and manually squeezed the brake with such force as to marginally weaken the impact of the collision. It so happened that Mr. Speight, chairman of the Railway Commissioners, was riding in the van just behind the engine of the express. He stated emphatically that Maskell's promptitude and presence of mind saved many lives on his train.

Hearing the tremendous noise of the crash, local residents in the area rushed to the scene.

The advancing express locomotive ploughed into the guard's van of the stationary train and three of the carriages, smashing them to fragments. The engine, in telescoping the rear part of the ordinary train, was nearly buried in debris. There was a huge mound of timber and ironwork, which, but for the presence of the remainder of both trains, was unrecognisable. The impact raised the guards van of the ordinary train into an upright position, from where it fell over onto the express engine, killing the

engine driver Frederick Maskell and James McNab, his fireman

Hearing the tremendous noise of the crash, local residents in the area rushed to the scene. Fading twilight had darkened into night and being at the base of a steep cutting, the mangled wreck made a very terrible sight, but care of the injured and recovery of the dead was the first priority.

Soon the scene was lit up by a beacon fire fed by the splintered wood from the destroyed rolling stock. The flames cast a weird, red light on the pale faces of the injured, many of which were contorted in pain, and revealed the horrible surroundings with ghastly distinctness. The terrors of the situation were intensified by the overpowering escape of steam from the ruined locomotive, deterring rescuers from immediately approaching to render assistance.

A short time later the firemen from the Prahran City, Windsor and South Yarra Brigades arrived on the scene. They had responded to the sound of the fire bell which rang out the alarm. They were soon joined by police and railway authorities.

Once the dangerous steam from the wrecked engine had cleared away, The Prahran City Brigade under Capt. Kelly were able to go into action. Their first task was to quench the flames in the fire box. Having accomplished this, their energies were directed to ascertaining the fates of Maskell and McNab. The engine had been running 'tender first' and the cab had been doubled back onto the furnace doors pinning the poor fellows. There appeared to be no time to think of self preservation judging from the attitudes in which their bodies were discovered. Both were badly scalded on their faces from the escaping steam and burnt from the heat of the furnace.

At one time during the chaos, a constable displayed strange behavior ordering Mr. Speight, chairman of the Railway Commissioners from the scene, even after the gentleman's identity was made known to the overly officious policeman. It was suggested that the Chief Commissioner of Police, Mr. Chomley, should administer a severe rebuke for such action. The constable in question then told Mr. Speight that since he declined to remove himself from the area, then he (the constable) would refuse to remove any persons who tried to hinder the work of the rescuers or the people endeavoring to clear the wreckage.

Within an hour of the collision all the dead and injured had been removed from the wreckage by a large number of people who had come to assist with the task. They had

been transported to hospitals, private houses and police stations.

In all, six people died, the engine driver Maskell, his fireman McNab, a female and a male passenger from the ordinary train were killed by the impact of the collision. The fifth person was Mr. E. Parkes, superintendent of the Melbourne branch of the Bank of Australasia. He was rescued from the wreck with two badly broken legs and conveyed to his home in Balaclava. There a doctor was attempting to amputate both his legs, when he died. The sixth person died some time later. In excess of 150 persons sustained injuries in varying degrees, one of the most serious being Mr. J. 'Cosmo' Newbery CMG, Director of the Technological Museum, Melbourne.

Another injured passenger was Mr. H. Butler, of Sargood, Butler & Co., Flinders Street Melbourne.

The speed and efficiency with which the dead and injured were removed was quite amazing, but the clearing of the track was even more remarkable. Under the organisation and supervision of a large number of police, the firemen, the railway authorities and a huge army of volunteers, aided by a large goods locomotive, worked diligently to dismantle the tangled wreck of the two trains into manageable units, which could be transported away or moved to the sides of the embankment. In less than three hours from the time of the collision, the trains resumed running to Brighton. A truly marvelous feat indeed!

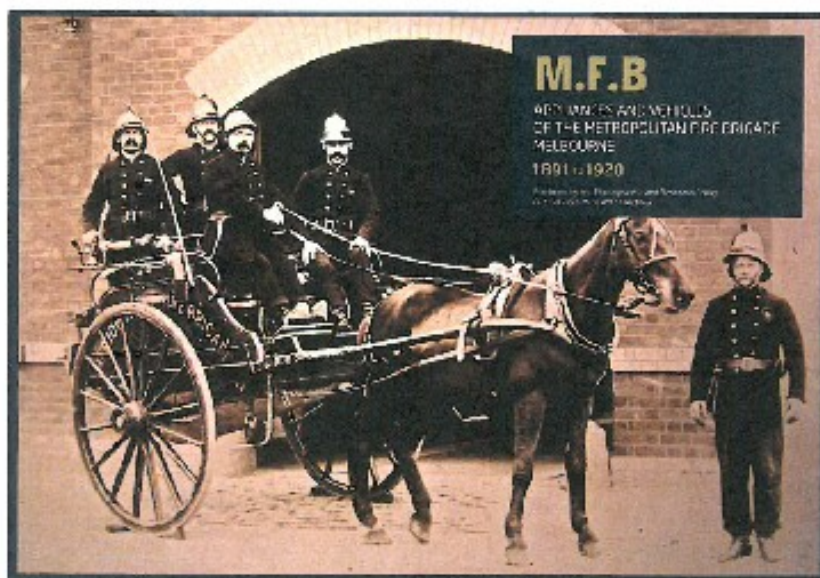
